# **New Business**

- Online Voting Process N. Lopez
  - Open discussion included a suggested online communication platform (ex. Slack, Teams, Mighty Networks).
  - Consensus is to continue the current process through email, but offer time for discussion (minimum of 48 hours, maximum of 5 days), followed by a 48-hour voting period.
- Ohio State Fish Designation Letter of Support P. Bode
  - Initiative by State Rep. Sean P. Brennan (D-Parma) to declare the walleye (native species) as Ohio's official state fish.
    - H.B. 599 is only a symbolic policy with no regulations or other stipulations.
      - On June 26, the bill was approved by the Ohio House by a vote of 94-2. It is expected to be discussed by the Ohio Senate in 5-8 weeks.

- Ohio is one of three states without an official state fish.
- As a multi-million-dollar industry, its economic impact is a main driver for the designation.
- The designation would align with the mission of the Cuyahoga River AOC as it represents that Lake Erie is a healthy ecosystem that can support a robust fishing industry.
  - Additionally, it could prompt the public to research the health of the river and subsequently, learn about the work of the organization.
- Motion to draft a letter of support for the designation of the walleye as Ohio's official state fish through public education on the mission of the Cuyahoga River AOC by P. Bode, seconded by S. Martin. All in favor with one abstention by B. Hughes.

# USEPA Great Lakes National Program Office Update – L. Medley

- *Revised* Management Action List (LOS Sent 6/20)
  - Expedited timeline due to the last quarter of GLNPO's fiscal year, thus presenting the final opportunity for funding approval until next year.
  - The *revised* MAP list was approved by U.S. EPA last week.
    - Included was the replacement of the Glenwillow Habitat Restoration with the Wood Creek Fish Barrier Removal (to be implemented by CMP) and changing the Station Road Habitat Restoration to 'design only' since it would not be able to be fully funded through the AOC.
  - Although not a common practice to modify the MAP list, it was a justifiable request. However, it would not be recommended to submit another revision.
    - It is anticipated to submit another modification to remove the Doan Brook Estuary Restoration from the MAP list.
- Currently working with the multiple dam removal projects in the Lower Cuyahoga to release for grant awarding.

# **OLEC Update – H. Boesinger**

- Introduction of Kris Patterson Lake Erie Program Administrator, Ohio Lake Erie Commission.
- BUI 10 (Beach Closings / Recreational Contact) Removal
  - The draft report was reviewed by the Advisory Committee and comments were submitted until June 27<sup>th</sup>.
  - The draft report is currently open for public comment until July 31<sup>st</sup>.
  - A public meeting will be hosted on July 17<sup>th</sup> at the Collinwood Recreation Center from 5:30-7p.
  - Justification for removal is based on evidence that proves AOC beaches are comparable to non-AOC beaches and continued issues can be linked regionally.
    - NEORSD uses a modeling program to predict beach closures advisories.
      - Raw data from the City of Akron and NEORSD on the Cuyahoga River main stem and Lake Erie show a decline trend in beach closures due elevated E. Coli concentrations.
    - Positive trends can be attributed to CSO programs throughout Northeast Ohio, but human impairments in the beaches will continue to remain after they are completed.
      - Removal of BUI will not affect continued monitoring of beaches and water quality by NEORSD and other agencies.
  - The Advisory Committee will be expected to provide a letter of support.
    - J. Stoll (SIP Subcommittee Chair) is in full support.
    - Motion to draft a letter of support for the BUI 10 (Beach Closures / Recreational Use) removal after the public comment period is concluded on July 31<sup>st</sup> by B. Hughes. Seconded by J. Stoll. All in favor, no abstentions.
