- Cuyahoga County's Fresh Water Institute, Founding Member Opportunity – B. Hughes
 - Attended a kick-off forum for interested organizations to become a founding member, in support of its three pillars: education and research, advocacy and access, and economic development. This could potentially be a new opportunity for the Advisory Committee.

USEPA Great Lakes National Program Office Update – S. La Gory

- Transition to S. La Gory, who will be taking over as the new task force lead.
- The current budget is operating under a continuing resolution, which is in effect through mid-March.
- Internal funding: A couple of projects are currently awaiting approval, including the Euclid Creek - E. 185th St. Spillway Fish Passage and the Boston Mills Restoration projects.
- Great Lakes Area of Concern (GL AOC) Conference: Sept. 16-18 in Toledo, OH
 - A limited number of travel scholarships will be available around March to interested members.

OLEC Update – H. Boesinger

- The West Creek Flume removal project is nearing completion, with only planting remaining in the Spring. NEORS is scheduled to conduct post-project monitoring.
- The Mayfield Sands Ridge project is currently under construction.
- The Beach Closings (Recreational Use) BUI 10a was removed in September 2024.
- Sampling for navigational dredging is being conducted by the Army Corps, with results to be released later this year. The BUI removal analysis will be led by OPEA, with potential removal slated for 2026.
- The Lake Erie Environmental Justice Program will be released early February, with an upcoming Request for Proposals expected to be due mid-April. OLEC plans to distribute one large grant of up to \$750,000 and up to five small grants of \$75,000 in the first cycle.

Announcements Pertinent to BUI Delisting Activities

- The Great Lakes Restoration Initiative Act of 2025, a federal funding program, is currently in Congress seeking reauthorization of up to \$500 million annually.
 - B. Hughes & S. Martin will be joining the Healing Our Waters-Great Lakes Coalition 2025 Great Lakes Days in Washington DC.
 - E. Price recommended the Advisory Committee to provide a letter of support. Majority agrees and B. Hughes will be drafting a letter for review.

- Acting in the best interests of the Cuyahoga AOC and recusing oneself from votes where there is (or may be perceived) a conflict of interest;
- Acting in full compliance with Ohio Ethics Law;
- Interpreting the Cuyahoga AOC's work and values for the community; and,
- Working in good faith with other Advisory Committee members, the Facilitating Organization, and Ohio EPA towards achievement of the agreed-upon common goals and priorities.
